II. Changing Receiver Channel

 Scan Automatically for a Non-interference Receiver Channel:

Press and hold the Channel Button for two seconds, the existing channel blinks. During blinking, press and hold for two seconds and it starts to scan automatically for a clear channel. Press again, the channel stops blinking and the new channel is saved.

(3) Press & hold for 2 seconds to scan for a clear channel.



(2) The existing channel blinks.



(4) Press again and the newly selected channel is saved



2. Manually Search for a Receiver Channel:

Press and hold the Channel Button **9** for two seconds, the existing channel blinks. During blinking, press and release, the number starts to go forward to the next channel in order (01, 02, 03, ... 11, 12, 01, 02) every two seconds. Press again, the channel stops blinking and the new channel is saved.





(3) Press & release to force for the next channel in order.



(2) The existing channel blinks.




(4) Press again and the newly selected channel is saved.



III. To Set Up ID Code

- MRM-58: 8 ID codes (d1-d8) can be selected. Select 'dP' to enter "pairing mode" for the 1-to-1 receiver to transmitter transmission. When paired and synchronized successfully via the ACT button with a transmitter, the receiver blocks signals from other MIPRO 5.8 GHz transmitters, and other receivers cannot receive the signal of the paired transmitter.
- 2. MRM-24: ID codes (d1-d8) can be selected.
- 3. Setting Instructions:
 - (A) Press and release the ID button , the LED screen shows the existing ID code: d1, d2, ... d8, dP. After two to three seconds, it will return to the existing channel display.
 - (B) Press and hold the ID button, the existing channel blinks. During blinking, press and release, the number starts to go forward to the next ID code in order (d1, d2, ... d8, dP) every two seconds. Press again, the number stops blinking and the new ID code is saved.
 - (C) Once the ID code is programmed, one must perform an ACT channel synchronization so the new ID code becomes effective.





IV. ACT Channel Synchronization

- When a new channel or ID code is set up. apply the ACT function to synchronize the transmitter
- 2. Press the ACT Button 2 on the receiver Existing channel 6 blinks.
- 3 Power on the transmitter and align the ACT Sync Windows 3 of both transmitter and receiver within 25 cm between each other for an automatic channel synchronization.
- If ACT channel synchronization is 4. performed successfully, the new channel in Channel Display Screen stops blinking and the RF Signal Indicator (3) will glow.
- To deactivate ACT channel synchronization. 5. just press and release the ACT Button again.
